- Ireland = 1.7 % of EU-27 land area
- 3.1 % of EU-27 farmland
- 9 % of EU-27 beef meat
- 5.2 % of EU-27 milk
- 13.6 % of EU-27 sheep & goats meat

Agroforestry support in Ireland

- Provided by Dept. Agri. Food & the Marine (DAFM)
 Forest Service
 - Exchequer funds (not Pillar II)
 - Afforestation Grant GPC 11
 - » Commenced 2014
 - Programme for Government
 - » Agroforestry included for first time



Afforestation Grant – GPC 11

- 5 × 5 m (400 stems ha⁻¹) / 6 × 1.5 (1,111 stems ha⁻¹)
- Free-draining mineral soil
- Max 100 kg N for pasture
- Minimum 0.5 ha, 20 m wide
- Square 4" stake + half-round & 1.5 m shelter
- Sheep / calves
- Poultry
- Max. 15% fruit/nuts
